

**CERTIFICATE OF LOCATION**

Corner No. 4, the NW Corner, is a 2"x2"x4" wood marked NW Cor P# 35.

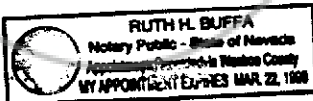
