The Claim is approximately 1500 feet long and 600 feet wide, such that 750 feet are claimed in a northwest direction and 750 feet in a southeast direction from the point of discovery (monument of location), at which this Notice of Location is posted, together with 300 feet on each side of the monument and center line of the Claim. The general course of the lode or vein is from the northwest to the southeast direction.
