22 claim and costs incurred in perfecting this lien claim.

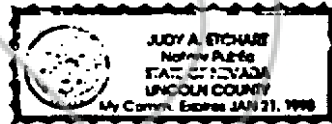

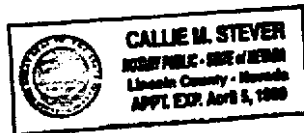
