

MAP NOTES

This survey is based on monument surveys by Richard Fonger P.L.S. 4235, and James Owens, P.L.S. 01278, neither of which are recorded.

Reference map: original Survey map of the West End Addition, City of Caliente, Lincoln County, Nevada, September 26, 1924 by Wm. Thorne, recorded document No. 3679, Plat Book A, Page 99. It is hereby noted that this map is presented without bearings. Additionally, Block C on Lincoln Street has 98.38 feet more length than there are lot frontages. The lots herein are proportioned easterly from the fence boundary between lots 14 and 15.

Lot 13 is divided equally based on front (Lincoln St) and rear (alley) dimensions.

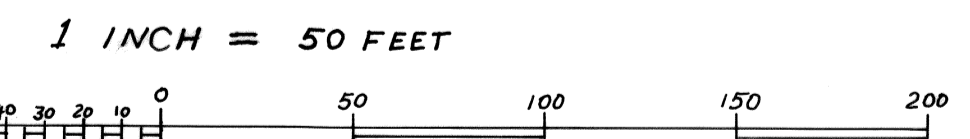

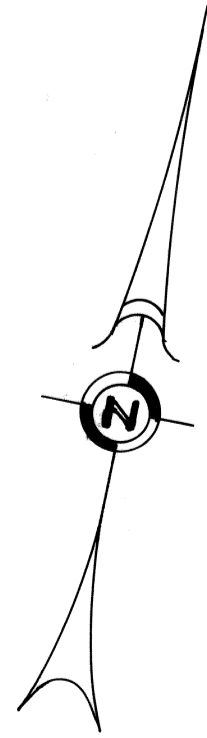
