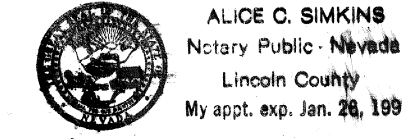

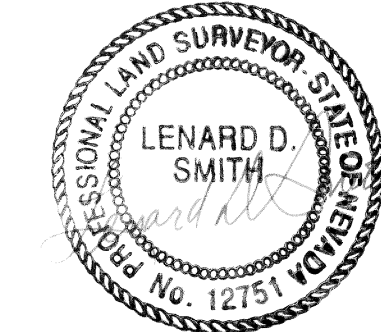

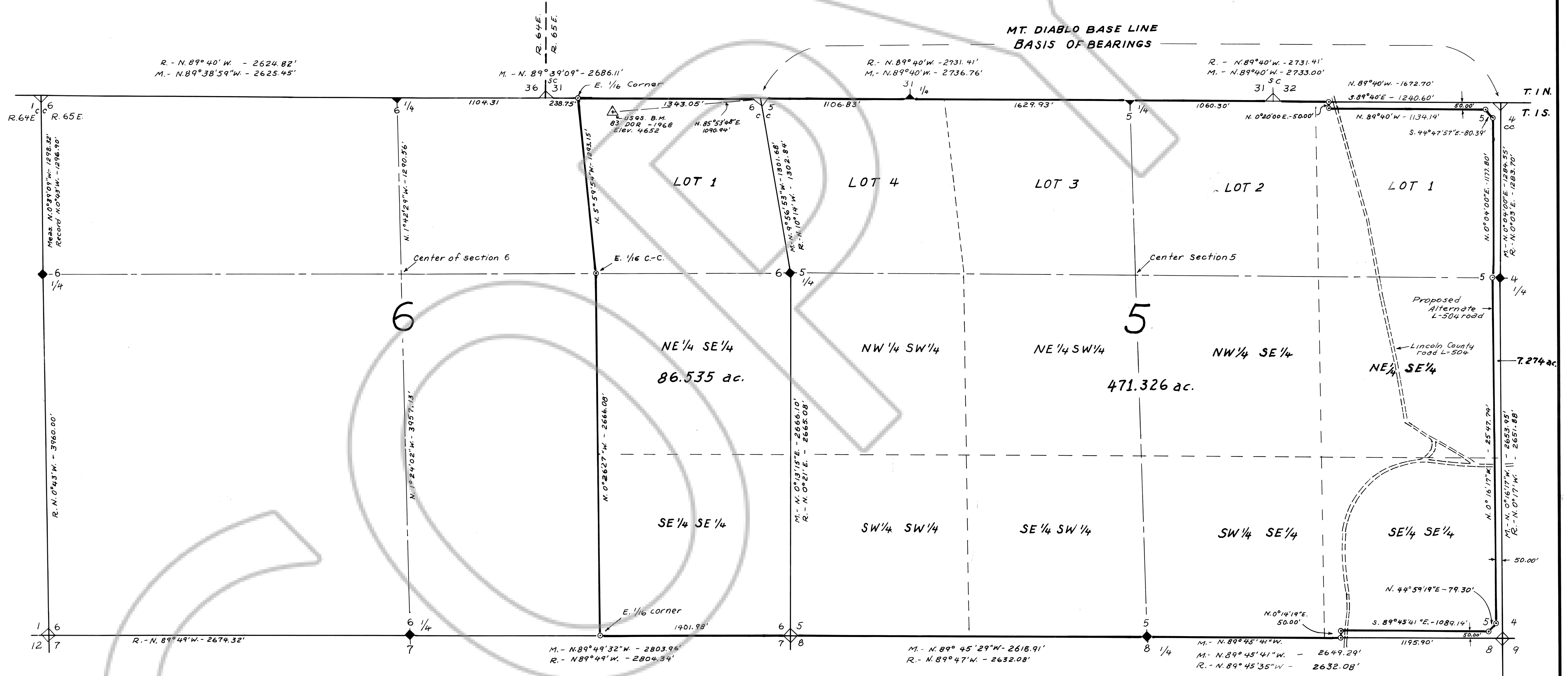


SURVEYOR'S CERTIFICATE

DEDICATION

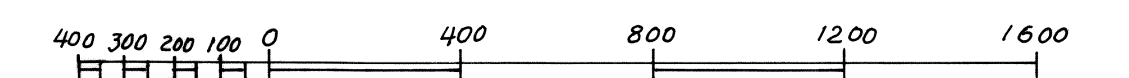
