Diagram of Claim—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the record of claim more perfect.

No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.

The claim must be distinctly marked on the ground, so its boundaries can be readily traced.

A severe penalty is provided by law for removing or defacing the stakes or monuments of a mining claim.

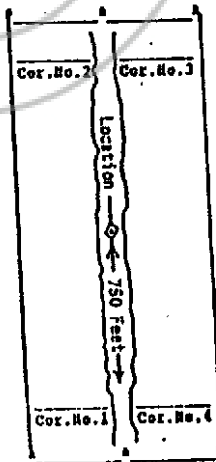
Claims located Sunday or holidays are legal.

DIAGRAM OF CLAIM

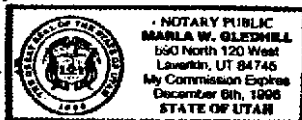
