Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" X 2" wooden posts four feet long Each monument is marked with a scribed metal tag, which states the claim name and number and the location of the monument with respect to the claim.
