BASIS OF BEARING

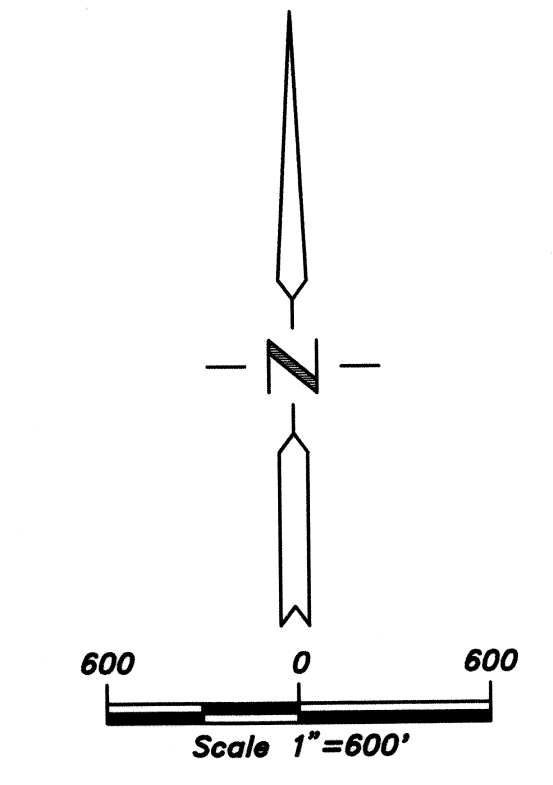
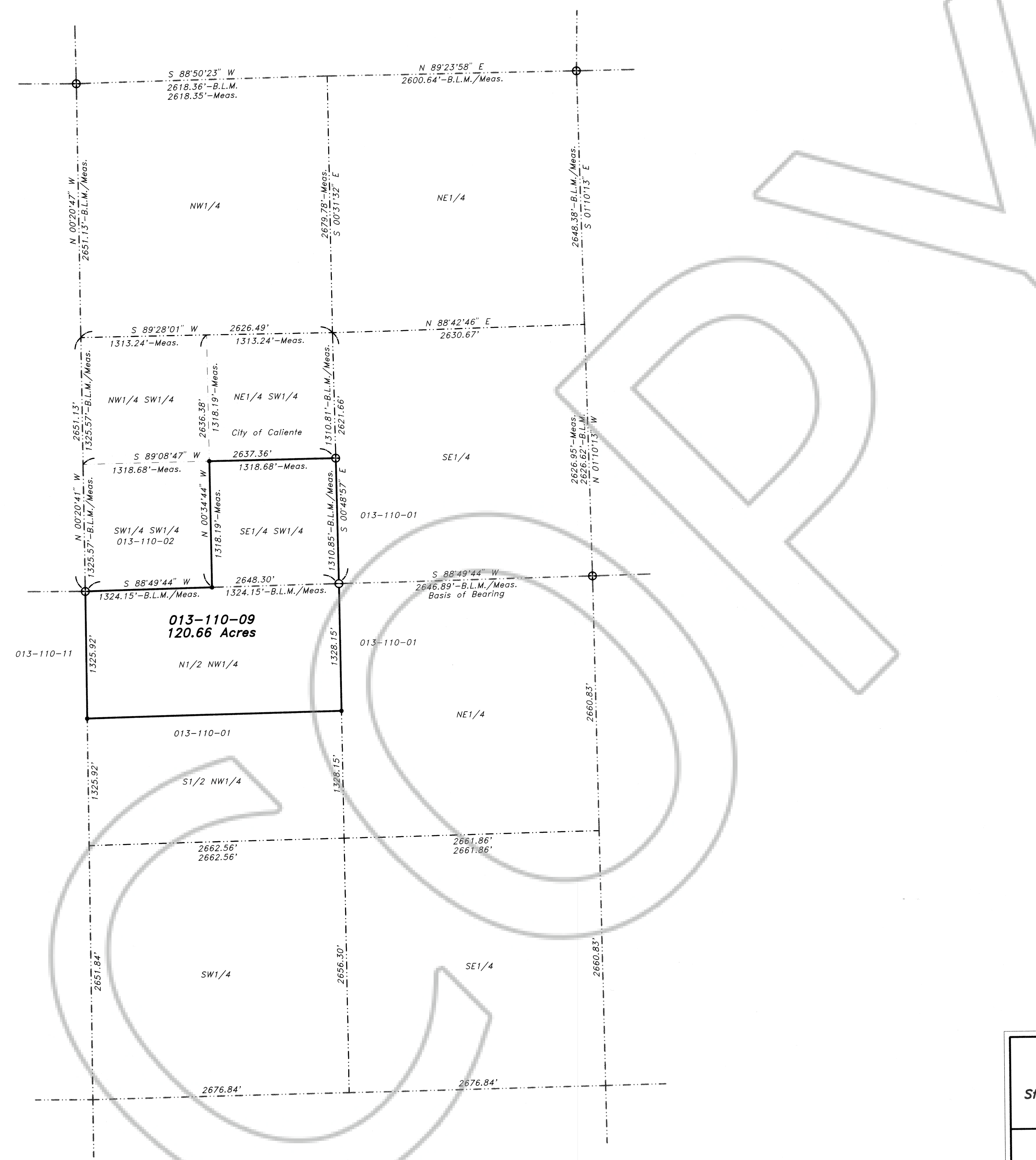
