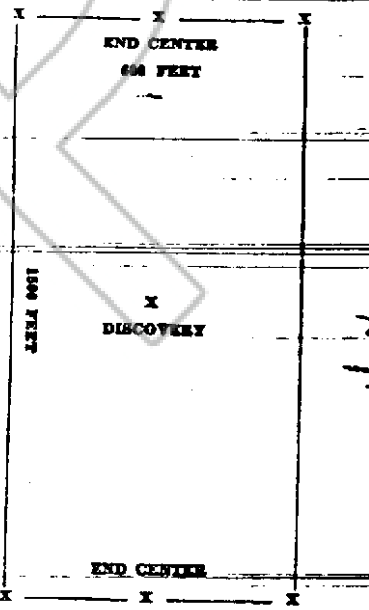


### Notice of Location

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Section 2324 of the Revised Statutes of the United States, and the laws, customs and regulations of this district, has have located Fifteen Hundred Feet in length by Six Hundred Feet in width, on this, the PURPLE RUN Lode, Vein, or Deposit, bearing Gold, Silver, Copper, Lead and other valuable minerals, situated in UNKNOWN Mining District, LINCOLN County,

follows, to-wit: Commencing 20 feet WEST of this location—discovery monument, at the WEST end center monument; and running thence 300 feet to the NW corner monument No. 1; running thence EAST 1500 feet to the NORTH EAST corner monument No. 2; running thence south 300 feet to the EAST end center monument; running thence south 300 feet to the south EAST corner monument No. 3; running thence WEST 1500 feet to the SW corner monument No. 4; running thence north 300 feet to the WEST end center monument, the place of beginning; including all dips, spurs, angles and variations. The ledge on this claim runs EAST - by - WEST.

NOTE

The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the record of the claim more perfect.  
 A mining claim may not exceed 1500 feet in length along the vein or lode, by 600 feet in width, 300 feet on each side of center of vein on the surface.  
 No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.  
 The claim must be distinctly marked on the ground, so its boundaries can be easily traced.  
 A severe penalty is provided by law for removing or defacing the stakes or monuments of a mining claim.  
 Claims located on Sunday or holidays ARE legal.  
 All valuable mineral deposits in lands of the Government are located by citizens of the United States only, and those who have declared their intention to become such.  
 This location notice must be filed for Record with the County Recorder of the county in which the claim is located, and a duplicate notice left at the discovery monument.
