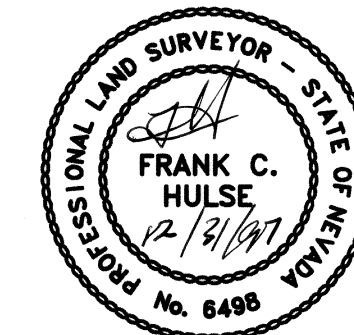


SURVEYOR'S CERTIFICATE

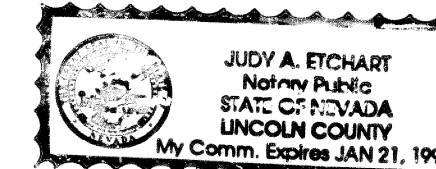

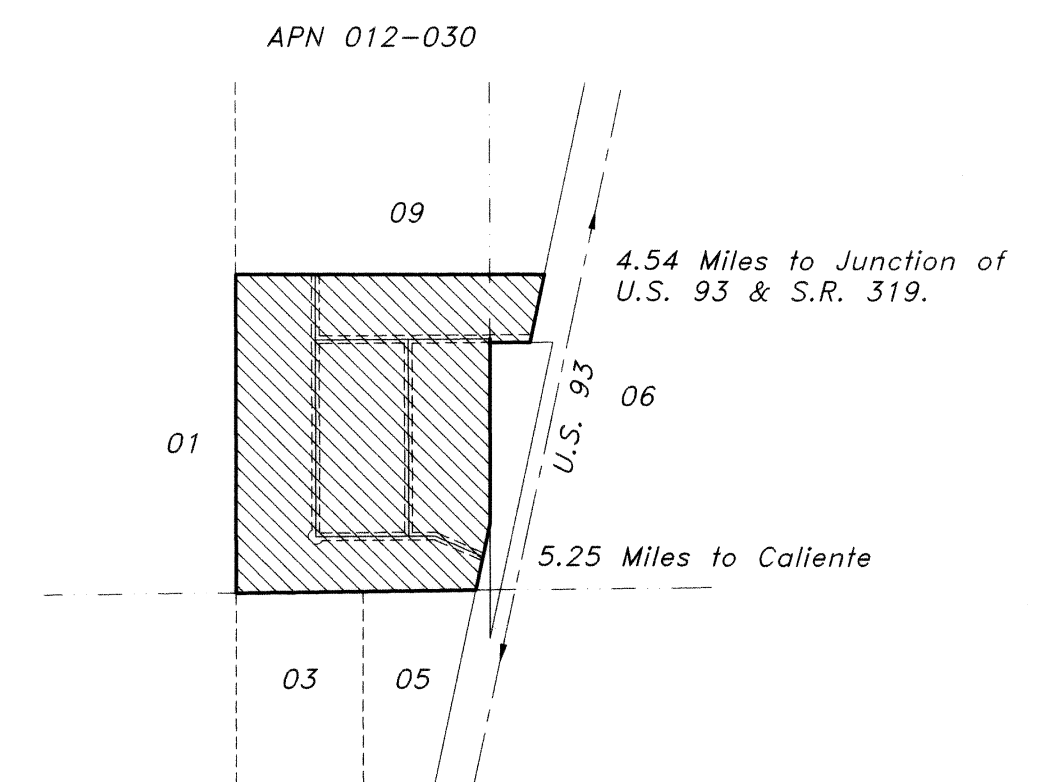
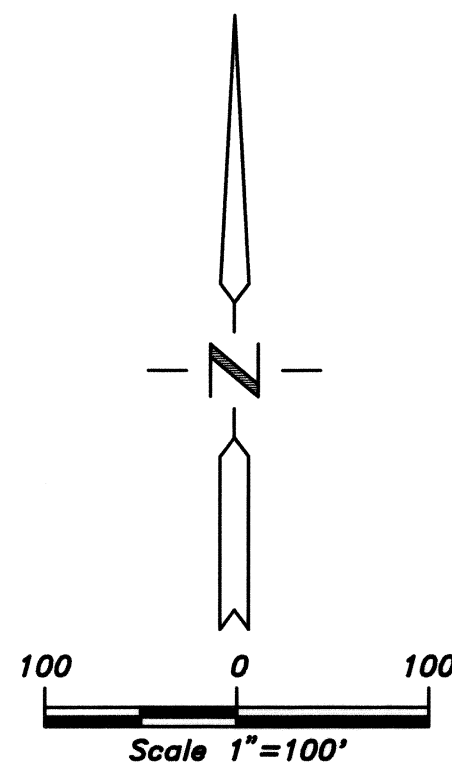
