

CERTIFICATE OF LOCATION

Corner No. 4, the SW Corner, is a 1½"x1½"x4" wooden post marked "SW P 29"

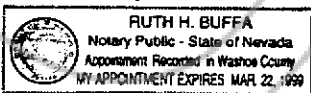
