

**CERTIFICATE OF LOCATION**  
State of Nevada Lode Claim

Corner No. 4, the SW Corner, is a 1½"x1½"x4' wooden post marked " SW P 370 ".

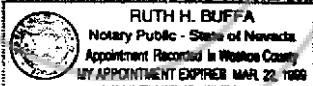
