

**CERTIFICATE OF LOCATION**

Corner No. 4, the SW Corner, is a 1 1/2"x1 1/2"x4' wooden post marked " SW P 372 "

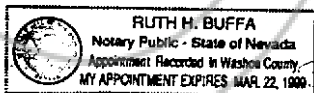
