

CERTIFICATE OF LOCATION

Corner No. 4, the SW Corner, is a 1½"x1½"x4' wooden post marked " SW P 1504 ".

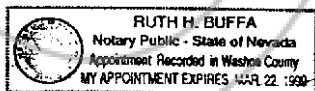
