MEMORANDUM OF AGREEMENT FOR OPTION, PURCHASE AND SALE OF WATER RIGHTS, REAL PROPERTY AND EASEMENTS

This Memorandum of the above entitled Agreement for Option, Purchase and Sale of Water Rights, Real Property and Easements dated the 27th day of 1998, by and between Coyote Springs Investment, LLC, a Nevada limited liability company ("Seller") and Southern Nevada Water Authority, a political subdivision of the State of Nevada, created by an Inter-Local Agreement on July 25, 1991, pursuant to Chapter 227, Nevada Revised Statutes ("Buyer"), (hereinafter "Agreement"), is to memorialize on the records of the County Recorders of Lincoln County and Clark County, Nevada, and on the records of the Nevada State Engineer of the Division of Water Resources of the Department of Conservation and Natural Resources of the State of Nevada, the terms and conditions of the Agreement in the following particulars:

 Subject to the provisions of the Agreement, the Buyer therein has purchased certain easement rights described as follows:

1.1. One Five Acre Exclusive Use Easement described on Exhibit A attached hereto together with one or two fifty foot wide Access Easements for an underground water transmission line or lines, an access road or roads, electrical lines and any other purposes necessary for the production and transmission of water from an existing well located within the Exhibit A property to Highway 93, said Access Easements being located upon the land described on Exhibit B attached hereto.

- 1.2. Five One Acre Exclusive Use Easements for future well sites, together with Access Easements from State Route 168 or Highway 93 for the purposes described above in paragraph 1.1, said easements being located upon the land described on Exhibit B attached hereto.
- 1.3. A General Easement over the Exhibit B land for the purpose of locating additional well sites together with Access Easements from State Route 168 or Highway 93 for the purposes described above in paragraph 1.1 above, said casements being located upon the land described on Exhibit B attached hereto.
- 2. At such time as definitive easements are recorded describing the easements identified in paragraph 1 above with particularity, the definitive easements shall thereafter determine the location of the easements described therein for all purposes of the Agreement.
- 3. The Agreement sets forth the terms of purchase by the Buyer named therein from the Seller named therein of 7,500 acre feet annually of water represented by the following water rights:
 - Uncertificated Permits 49414, 49660, 49661, 49662, 49978,
 49979, 49980, 49981, 49982, 49983 and 49984 issued by the Nevada
 State Engineer on November 13, 1997.
 - 3.2. The above described water rights shall be free of liens and encumbrances or claims by others.

- 5.3. Buyer named in the Agreement shall have the first priority right under the above Permits to take its water from the existing well located within the Exhibit A land (the "MX Well"). This first priority right is to take up to 7,500 acre feet annually from the MX Well, as provided in the Agreement, on a first priority basis before Seller can obtain any of its unsold or reserved water from the MX Well, as such water is defined in the Agreement.
- 3.4. In the event the MX Well does not have sufficient productive capacity for all of the water rights described in the Agreement, any wells drilled in Coyote Springs Valley by either Buyer or Soller named in the Agreement shall be placed and drilled so as not to adversely impact the productive capability of the MX Well.
- 3.5 In the event the Novada State Engineer determines that the appropriation of public waters in Coyote Springs Valley must be reduced, Seller's Reserved Water as defined in the Agreement will be reduced first so that Buyer's rights are not diminished.
- 4. The Agreement provides that this Memorandum shall be filled with the Nevada State Engineer for inclusion in the files of all of the permits described above in paragraph 3.1 hereof.
- The Agreement is hereby referred to and incorporated in this Memorandum for further
 particulars respecting the rights of the parties with respect to the subject matter hereof.

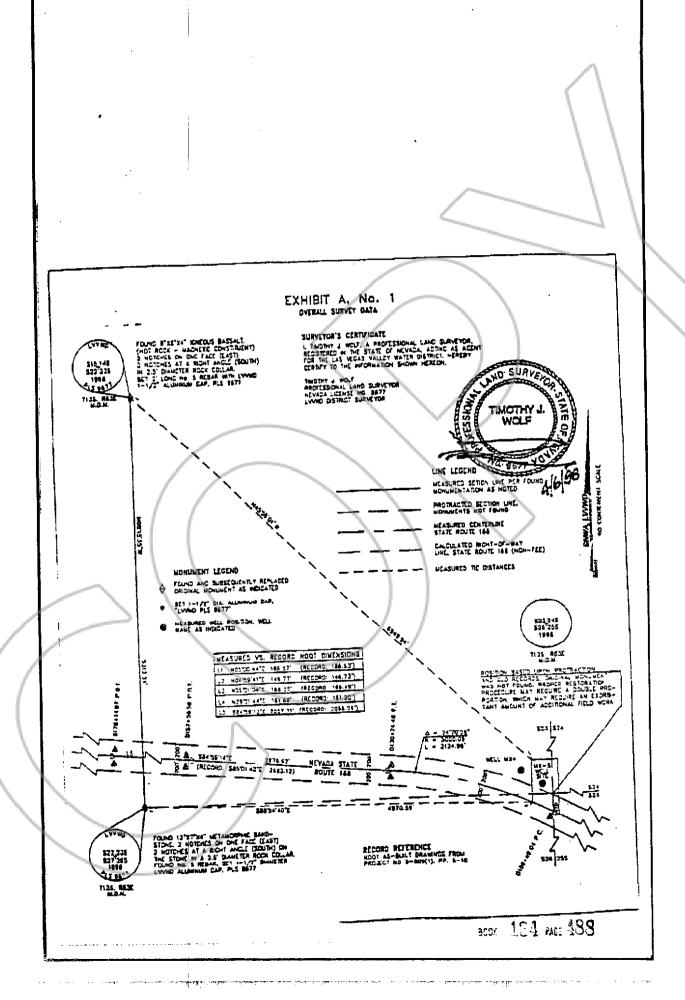

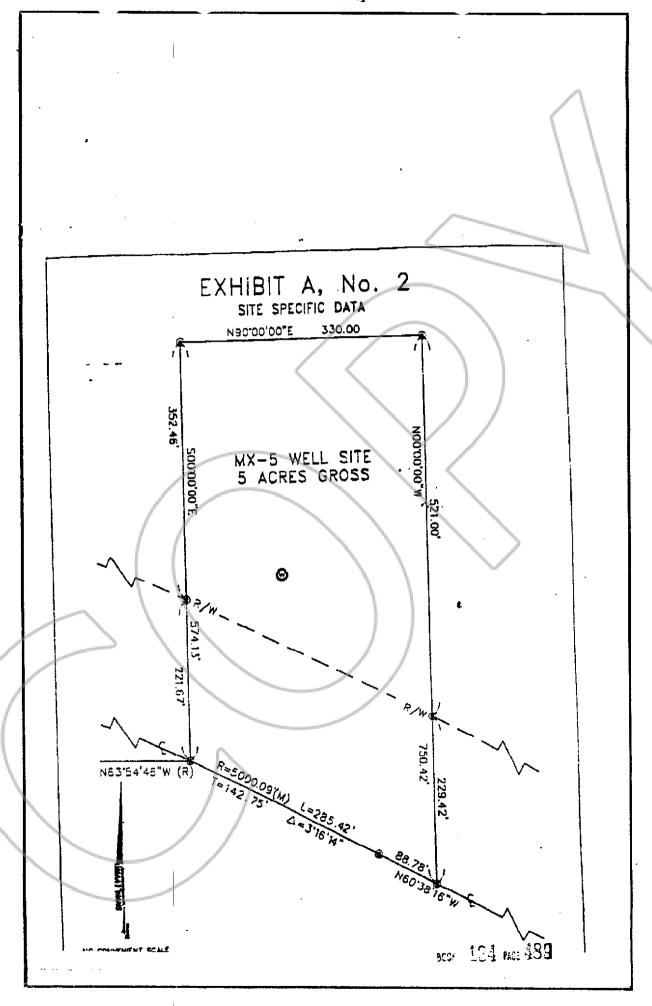
