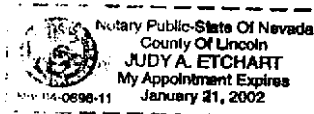

EXHIBIT "A"

Commencing at a point which is S. 27° 57' W and a distance of 4757.0 ft from the NW Corner of Section 28, Township 1 North, Range 67 East, MDB&M, and known as the Hoover Dam-Pioche Power Line Station 36+51.6, which is the intersection of the Hoover Dam-Pioche Power Line with the center line of the Prince Mine Railroad, proceed S 55° 50' 20" E a distance of 1004.70 ft to survey station CHR 1001; thence N 51° 14' 20" E a distance of 2392.76 ft to survey station CHR 1002; thence S. 53° 58' 44" E a distance of 682.36 ft to survey station CHR 1009; thence S 23° 13' 01" E a distance of 266.14 ft to Corner No. 1 of Lot 18, this point being the beginning of the Lot 18 survey; thence N. 23° 04' 29" W a distance of 145.75 ft to Corner No. 2 of Lot 18; thence N 68° 50' 31" E a distance of 158.80 ft to Corner No. 3 of Lot 18; thence S. 21° 38' 05" E a distance of 151.23 ft to Corner No. 4 of Lot 18; thence S 70° 54' 05" W a distance of 154.92 ft to Corner No. 1, this point being the beginning of this survey.

The property consists of 0.53 acres more or less, , together with that certain structure consisting of a five (5) bedroom wood frame house located thereon. Three-quarter inch pipes have been set at all property corners.
