Thence N. 06'28'48" E. a distance of 100.00 feet;


Thence S. 83'21'12" E. a distance of 107.00 feet;

Thence S. 83'21'12" E. a distance of 20.00 feet;


Thence S. 06'28'48" W. a distance of 20.00 feet; Thence N. 83'21'12" W. a distance of 20.00 feet;
