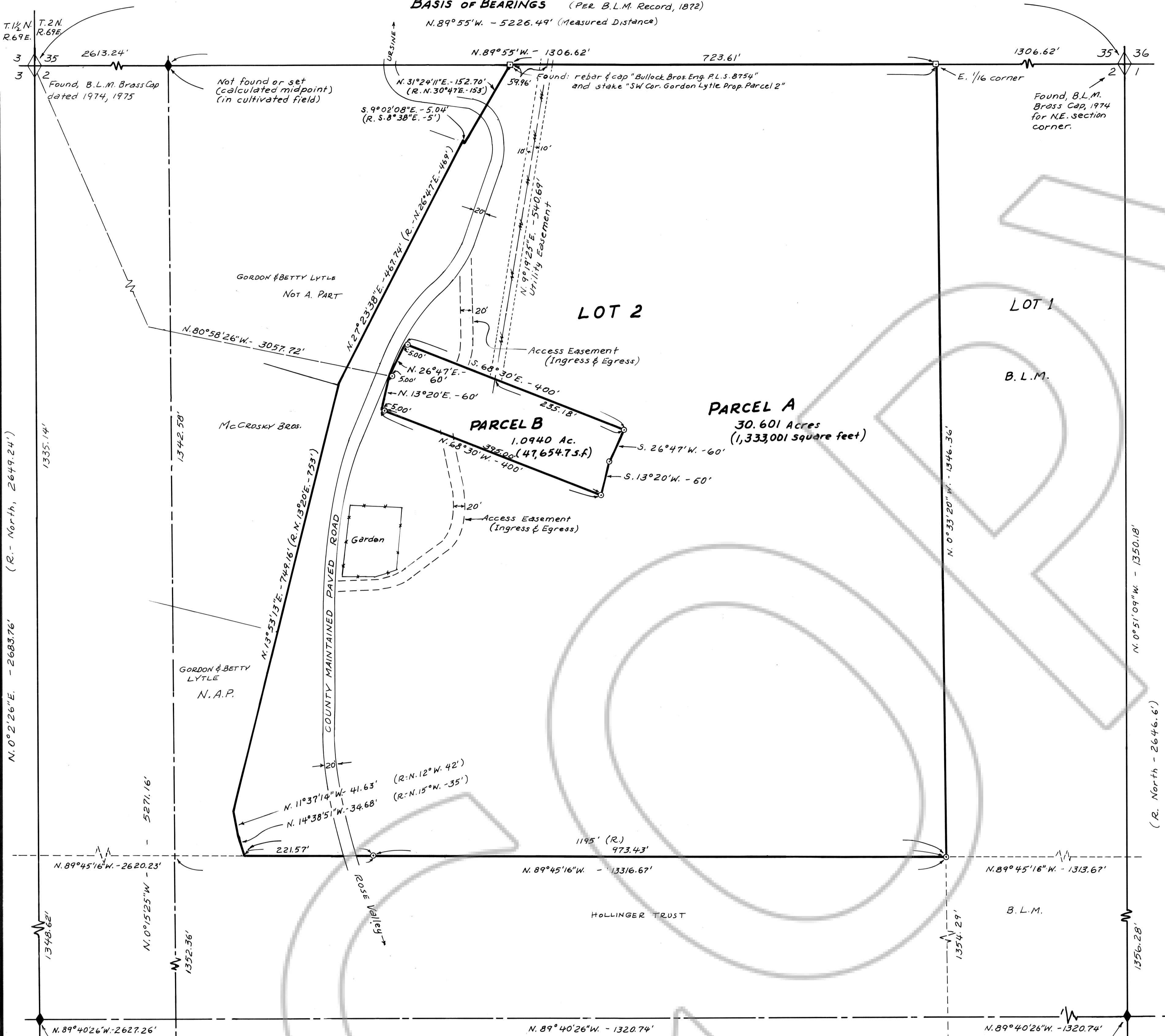


**BASIS OF BEARINGS** (Per B.L.M. Record, 1872)

**MAP NOTE**

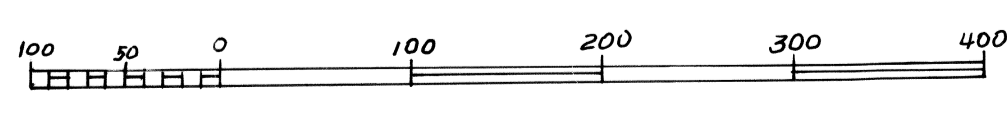
