

QUITCLAIM DEED

THIS QUITCLAIM DEED, Executed this 28th day of August, 1998

PERKINS AND GERI PERKINS, husband and wife as joint tenants, with full right of survivorship, whose address is 59 Richardville Road, Alamo, NV 89001 for the sum of TEN AND NO/100 _____ DOLLARS, the following described tract of land in the, County of Lincoln, State of Nevada, as follows:

A parcel of land situate in Pahrnagat Valley, Lincoln County, Nevada described as: Commencing at the north quarter corner of Section 32, Township 6 South, Range 61 East, MDB&M, and running thence South 1 degree 30'13" East a distance of 1065.28 feet to a point being on the Northeast right-of-way line of the frontage road (formerly Highway 93 before realignment); thence North 50 degrees 41'00" West a distance of 616.01 feet along the Northeast right-of-way line of the aforementioned frontage road to the TRUE POINT OF BEGINNING; thence North 39 degrees 19'00" East a distance of 175 feet to a point; thence South 50 degrees 41'00" East a distance of 125.01 feet to a point; thence South 39 degrees 19'00" West a distance of 175 feet to a point; thence 50 degrees 41'00" West a distance of 125.01 feet to the TRUE POINT OF BEGINNING.

Also, a one-fourth(1/4) interest in and to the following-described parcel of land situate in Pahrnagat Valley, Lincoln County, Nevada, described as: Commencing at the north quarter corner of Section 32, Township 6 South, Range 61 East, MDB&M and running thence South 1 degree 30'13" East a distance of 359.61 feet to a point; thence South 88 degrees 29'47" West a distance of 30 feet to a point; then South 1 degree 30'13" East a distance of 253.90 feet to the TRUE POINT OF BEGINNING; thence South 88 degrees 29'47" West a distance of 80 feet to a point; thence North 1 degree 30'13" West a distance of 60 feet to a point; thence North 88 degrees 29'47" East a distance of 80 feet to a point; thence South 1 degree 30'13" East a distance of 60 feet to the TRUE POINT OF BEGINNING.

Together with any and all improvement situate thereon.

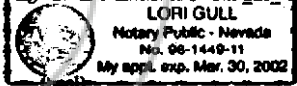
