CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY THAT, in accordance with the requirements of Title 30, United States Code, Section 23, and the local laws, customs, and requirements of this state, the BOW No. 105, Lode Mining claim was located by White Knight Gold (US) Inc. on the 6 th of September, 1998.

The claim is 1500 feet long and 600 feet wide, and 1490 feet is claimed in a north direction and 10 feet in an south direction from the discovery monument, at which the Notice of location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center line of the claim. The general course of the lode deposit and premises is from the north to the south.

The claim is located in the surveyed/protracted NE & SE 1/4's S.23, NW & SW 1/4's S.24, T4N, R63E, M.D.B.M., Bristol Mining District, Lincoln County, State of Nevada, and is more particularly described by metes and bounds as follows:

Beginning at Corner No. 1 which is the southwest corner of the mining claim, thence north a distance of 1500 feet to Corner No.2 which is the northwest corner of this mining claim; thence east a distance of 600 feet to Corner No. 3 which is the northeast corner of this mining claim; thence south a distance of 1500 feet to Corner No.4 which is the southeast corner of this mining claim; thence west a distance of 600 feet to Corner No.1, the point of beginning.

Claim boundaries are monumented by wooden posts at least 1.5 inches in diameter by 4 feet in length, set one foot in the ground, one at each corner of the claim. Each corner contains markings sufficient to appropriately designate it as a corner of said claim.

Beginning at Corner No.1 which is the southeast corner of this claim, thence a distance of 18,230 feet south and 5200 feet west to the following natural object or permanent monument, to wit: The Southwest Corner of Section 2, Township 3 North, Range 63 East, Mount Diablo Base Meridian, State of Nevada.

The work of location consisted of making a claim map as provided in N.R.S. 517.040, as amended 1985.
