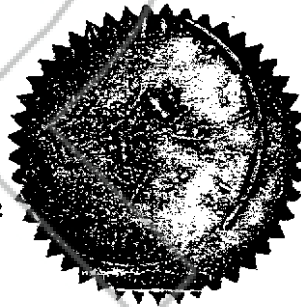

The plaintiffs Stephen Irwin and Paul Kalvin having duly moved for an Order directing summary judgment in their favor and against defendant Combined Metals Reduction Company on plaintiffs' causes of action for mutual mistake; unjust enrichment and money had and received; and the motion having come to be heard before Justice Carol E. Huff, at an I.A.S.
