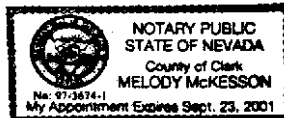

COMES NOW AFFIANT Glen J. Lewis, and having been duly sworn upon his oath, does state as follows:

1. AFFIANT is over the age of eighteen (18) years and is competent to make this AFFIDAVIT.

4. AFFIANT has performed all of his required labor in good faith under said Employment Agreement.


5. To the date of this affidavit, AFFIANT is due the sum of \$5,651.00, as follows:

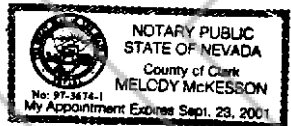
- \$750.00 wages due for week of December 7, 1998




EMPLOYMENT AGREEMENT
