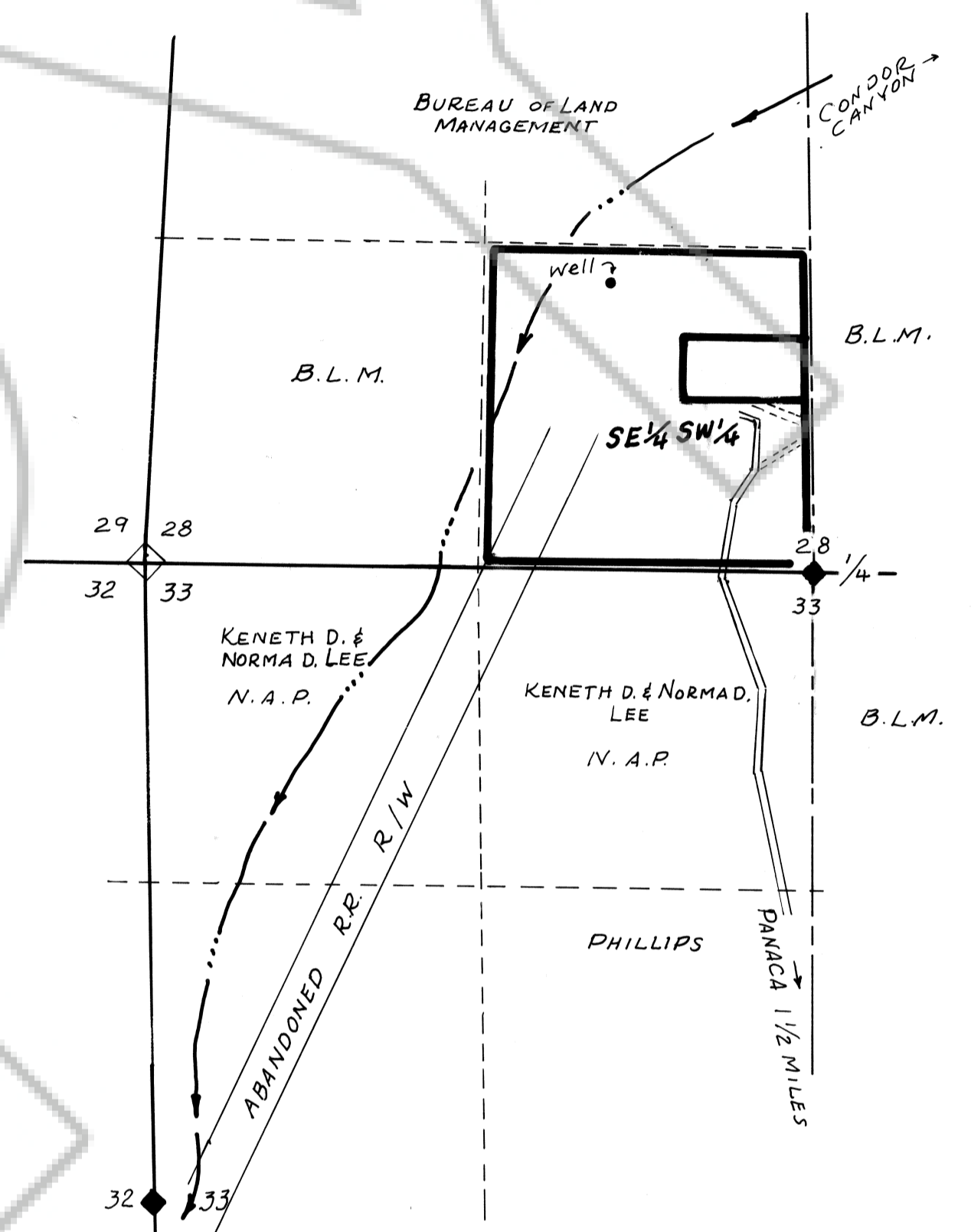
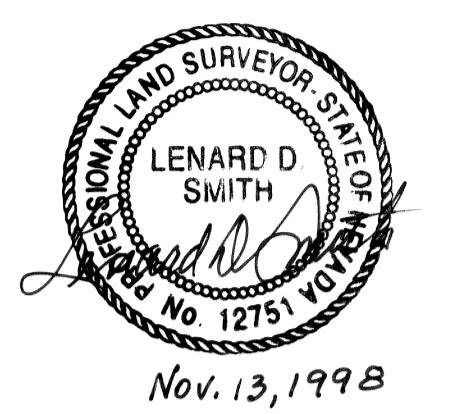


SURVEYOR'S CERTIFICATE

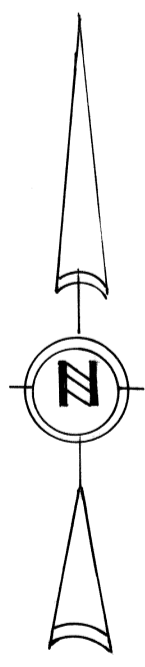
VICINITY MAP

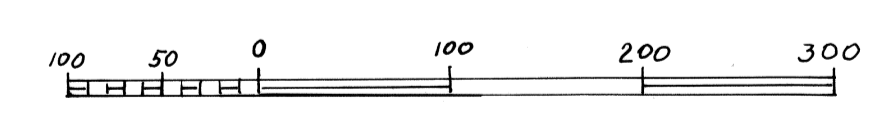
○ Set 5/8" rebar with cap stamped L. Smith PLS 12751

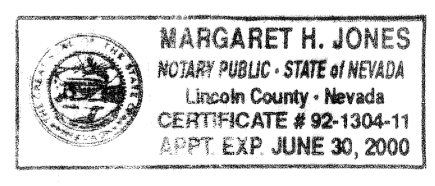
