SURRENDER OF OIL AND GAS LEASE IN WHOLE

WHEREAS, Under date of June 1, 1994, the Secretary of the Interior of the United States, pursuant and subject to the terms and provisions of the Act of Congress, approved February 25, 1920 (41 Stat. 437), as amended, issued that certain Oil and Gas Lease bearing Serial Number N-58283 to Winn Exploration Co., Inc., recorded in Book 248, Page 151, Entry 293766 of the records of White Pine County, Nevada and Book 116, Page 372, Entry 104390 of the records of Lincoln County, Nevada and covering the following described lands situated in Lincoln and White Pine Counties, Nevada, to-wit:

WHEREAS, Hunt Oil Company of Nevada, 1445 Ross at Field, Dallas, Texas 75202, is the present owner and holder of said Oil and Gas Lease and all rents, royalties, and other obligations due and payable under said lease have been duly paid to the United States of America and there is not now due or owing any wages or monies to workmen employed in operations conducted on the above described lands, and the public interest will not be impaired if said lease is surrendered in its entirety; and full provisions for the conservation and protection of the said property have been made by the Assignee; and

WHEREAS, Hunt Oil Company of Nevada now desires to surrender to the United States of America, pursuant to the right of surrender, contained in said lease, all of the above described lands.

NOW, THEREFORE, for and in consideration of the premises, the undersigned, Hunt Oil Company of Nevada, the present owner of said lease, does hereby surrender, release, assign and relinquish to the United States of America all of its right, title and interest in and to the lands described above.
