SURVEYOR'S NOTE

The Data for Sec. 13, was taken from the G.L.O. Field Notes & Map of the 1881 Survey of T. 9 N., R. 65 E., M.D.M.. No Corners were found to establish the location of the Section Corners, therefor the notes from the above mentioned survey were used to determine the recorded location of said corners.

BASIS OF BEARING

The Basis of Bearing was established using G.P.S. from a known U.S.G.S. Control Station described as 'GEYSER', using NAD83 Coordinates, and established a local Control Station on a G.L.O. B.C. described as the NW Cor. of Sec. 13, T. 9 N., R. 65 E., M.D.M..


