Pursuant to the authority contained in sec. 3(d) of Executive Order 11988 of May 25, 1977 (42 FR 26951) and the Act of March 3, 1877, as amended and supplemented (43 U.S.C. 321, et seq.), this deed is subject to a restriction which constitutes a covenant running with the land, that the portion of land lying within the 100-year flood plain, more specifically described as 100 feet either side of the Patterson Wash main channel, may be used only for agricultural purposes or for park and nonintensive open space recreation purposes, but not for dwellings or buildings.

SUBJECT TO:

 Those rights for an existing access road of Lincoln County No. 80, or Pioche to Hamilton Stage Route, its successors or assigns, constructed under the provisions of Revised Statute 2477, 60 feet in width, in favor of Lincoln County, to insure continued ingress and egress to adjacent lands, as to the NW%NW%, section 22, T. 2 N., R. 67 E., M.D.M., Nevada.
