

CORRECTING DEED

This indenture witnesseth: that we, Gail Foremaster and William Jay Schofield, trustees of the Merle F. Schofield Family Trust, do hereby file this correcting deed to clarify any right title and interest in that certain piece of real property as herein described within the County of Lincoln, State of Nevada:

A parcel of land situate within the SE1/4 of the NE1/4 of Section 34, and the SW1/4 of the NW1/4 of Section 35, all within Township 4 South, Range 60 East, Mount Diablo Meridian, being more particularly described as follows:

Beginning at a point on the boundary between Section 34 and 35, T4S, R60E, M.D.M. from which the Northeast Corner of said Section 34 bears N 00° 17' 46" W a distance of 1,335.48 feet, thence S 89° 38' 56" E a distance of 359.47 feet to the Northeast Corner; thence S 01° 20' 51" E a distance of 279.35 feet to a point; thence S 89° 39' 27" W a distance of 145.52 feet to a point; thence S 01° 20' 51" E a distance of 150.64 feet to the Southeast Corner; thence S 89° 36' 34" W a distance of 450.12 feet to the Southwest Corner; thence N 01° 20' 51" W a distance of 175.91 feet to a point; thence N 83° 28' 32" W a distance of 549.90 feet to a point on the Easterly boundary of the State Route 318; thence N 02° 33' 14" E a distance of 201.79 feet to the Northwest Corner; thence S 89° 21' 29" E a distance of 767.49 feet to the point of beginning. Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining.

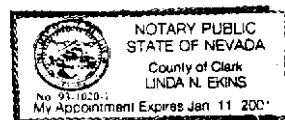
