WHEREAS, on April 8, 1998 the Owner of said note executed and delivered to Trustee written Declaration and Default and Demand for Sale, and pursuant thereto a Notice of said Breach and Default and of Election to cause Trustee to sell said property to satisfy the obligation secured by said Deed of Trust was recorded on August 19, 1998 in Book 136 of Official Records, page 527 as Document No. 111463 in the Office of the County Recorder of said County; and
