

CORRECTED DEED

THIS INDENTURE made this _____ day of _____ October 1993 between David J. Barnett and Stephanie Rollins (AKA Stephanie Barnett), the parties of the first part, and Dale Blair and May E. Blair, husband and wife, the parties of the second part,

WITNESSETH: That the said party of the first part for valuable consideration paid by the said party of the second part, the receipt of which is hereby acknowledged, does by these presents grant, bargain and sell unto the party of the second part all that certain real property located in the City of Caliente, County of Lincoln, State of Nevada to wit:

A parcel of land situate within the SW 1/4 of the NW 1/4 of Section 8, and the SE 1/4 of the NE 1/4 of Section 7, all within Township 4 South, Range 67 East, Mount Diablo Meridian, being more particularly described as follows:

Beginning at a point of the Section Line between said Section 7 and Section 8, T4S, R 67 E, M.D.B. & M., from which the Southeast Corner of Section 7 (SW Corner of Section 8) bears S 0°07' 54" W a distance of 3,535.62 feet, thence S 80°31' W a distance of 212.10 feet, thence S 76°53'01" W a distance of 215.87 feet to the Southwest Corner, thence N 26°42' W a distance of 149.85 feet to a point, thence Due North a distance of 406.47 feet to the Northwest Corner, thence S 89°08'26" E a distance of 487.86 feet to a point on the Section Line (between 7 & 8); thence continuing S 99°54'05" E a distance of 443.50 feet to the Northeast Corner, thence Due South a distance of 201.78 feet to the Southeast Corner; thence S 30°30' W a distance of 221.80 feet to a point, thence S 80°31' W a distance of 336.50 feet to the point of beginning. Parcel contains 5.27 acres within Section 7, and 4.00 acres within Section 8, for a total of 9.27 acres all within T4S, R67E, M.D.B. & M.


