 3 interest thereon at the highest legal rate from October 1, 1998, to the present, in the sum of
 4 \$6,850.53, and interest on the principal sum from entry of Judgment until paid in full, together with
 5 the Plaintiff's attorney's fees pursuant to NRS 108.237(3) in the amount of \$ 5,500.00, and
 6 costs in the amount of \$607.21.

7 IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that the Clerk of the Court
 8 is hereby authorized and instructed to pay Plaintiff the total amount of this judgment from the funds
