**CERTIFICATE OF LOCATION OF LODE MINING CLAIM

Said claim is a lode, it being situated in the above-mentioned County and State, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden posts four feet long.
