**CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that:

has located the MN 186 Lode Mining Claim on the 1st day of September, 1999 whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above-named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is a lode, it being situated in the above-mentioned County and State, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 600 feet south to the SE corner (Cor. No. 2), thence 1500 feet west to the SW Corner (Cor. No. 3), thence 600 feet north to the NW corner (Cor. No. 4), thence 1500 feet east to the Point of Beginning.

To tie this claim to a Public Survey, the NE Corner (Cor. No. 1) of this claim lies approximately 4200 feet North and 7500 feet West from the SE Corner of Section 29, Township 1 N, Range 71 E, Mount Diablo Base Line and Meridian.


