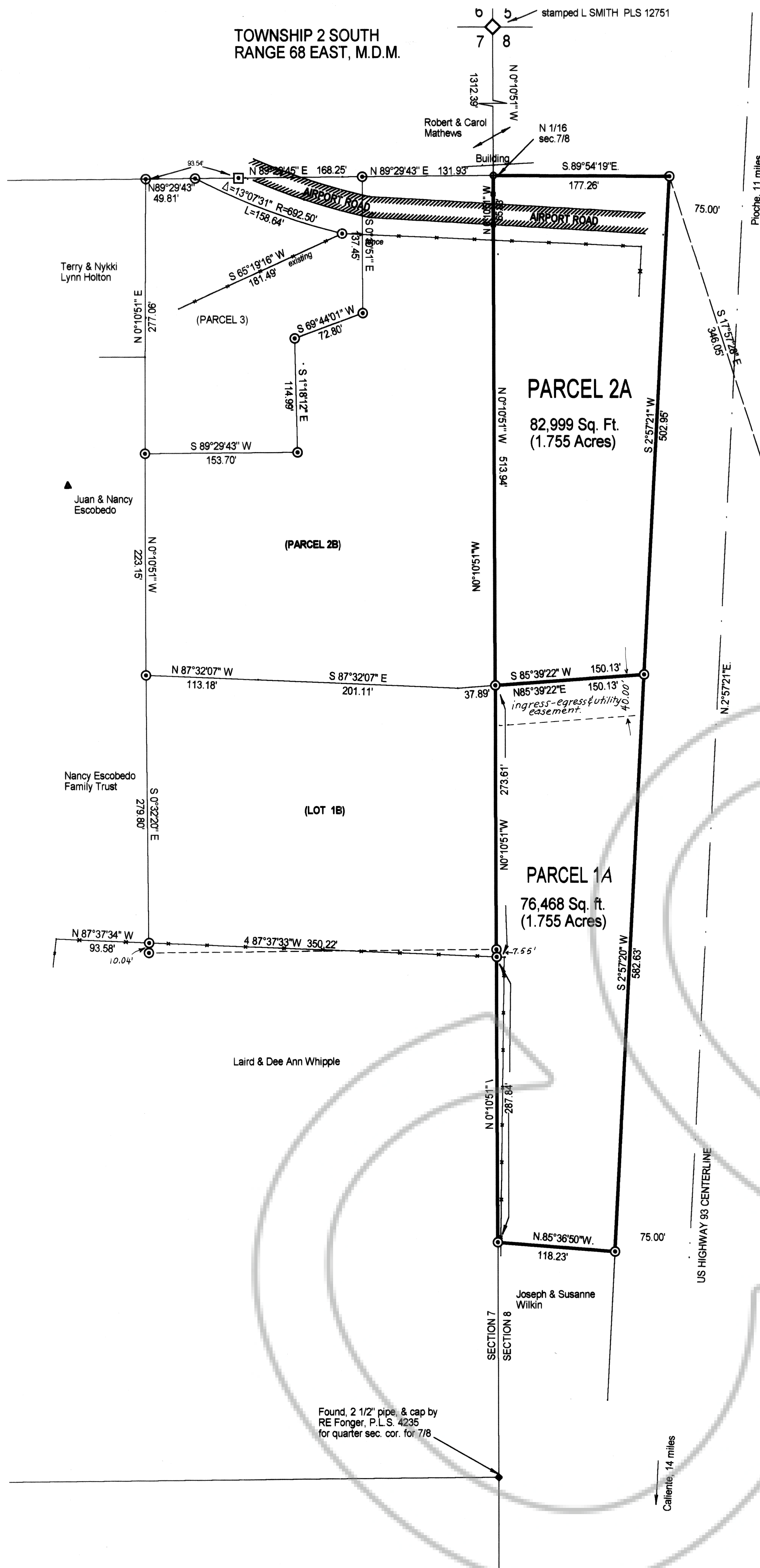
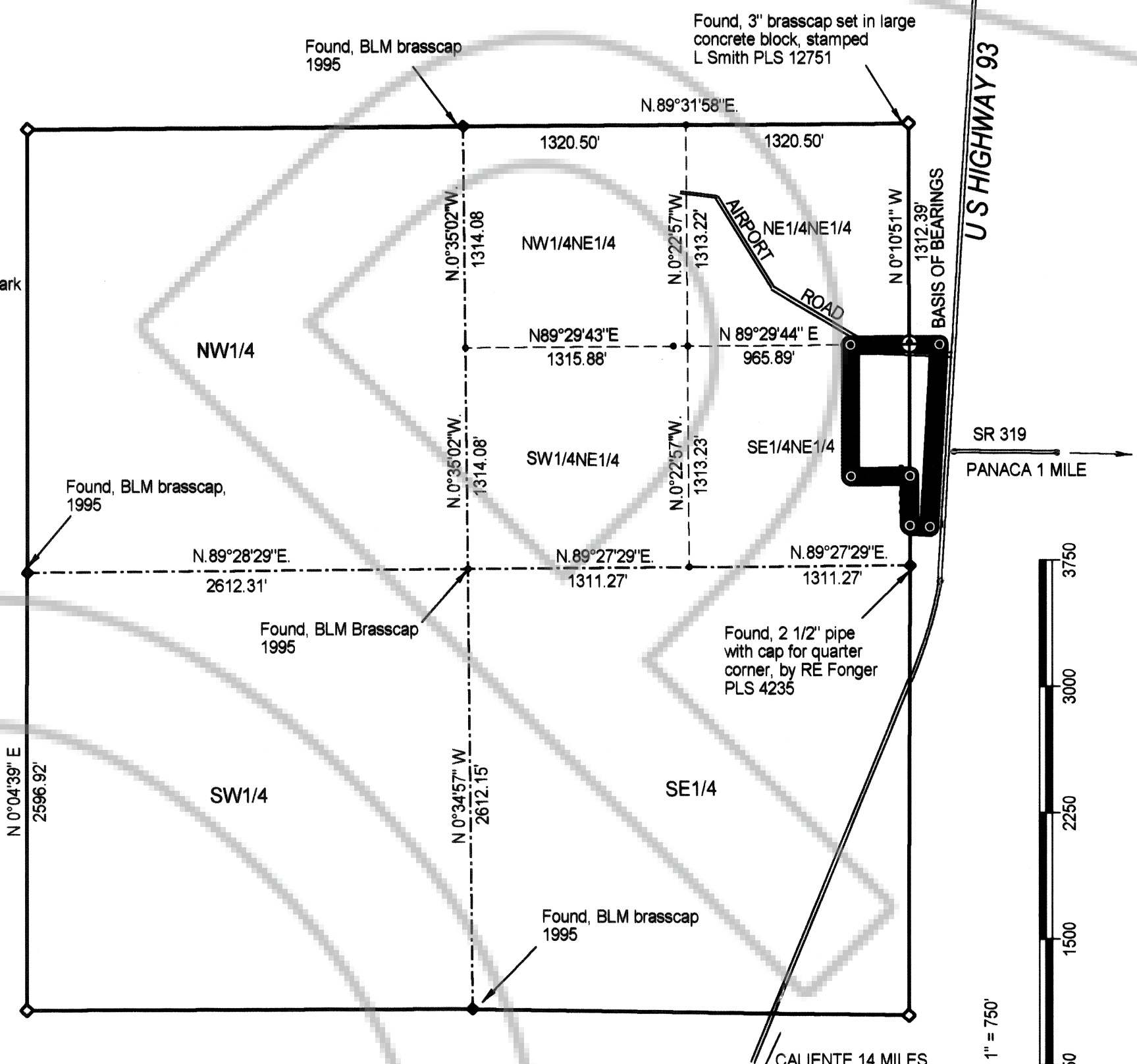


TOWNSHIP 2 SOUTH

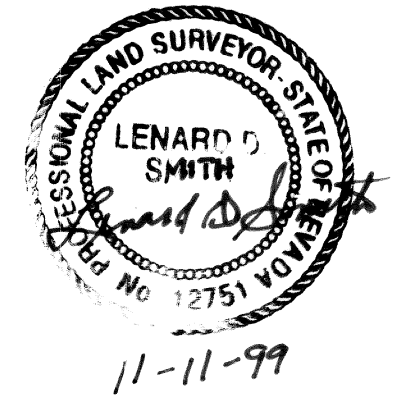
At the regular meeting of the Lincoln County Planning Commission held this 14 day of Jan, 2000, this plat was examined and we do hereby recommend it for approval.

4. The monuments depicted on the plat are of the character shown, occupy the positions indicated, and are of sufficient durability.



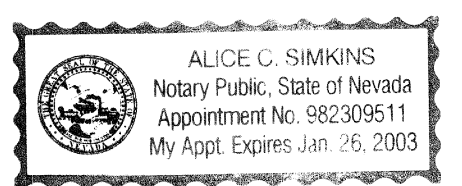

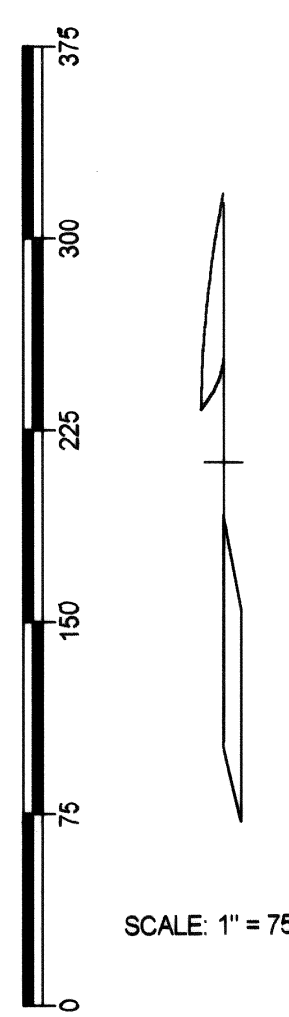
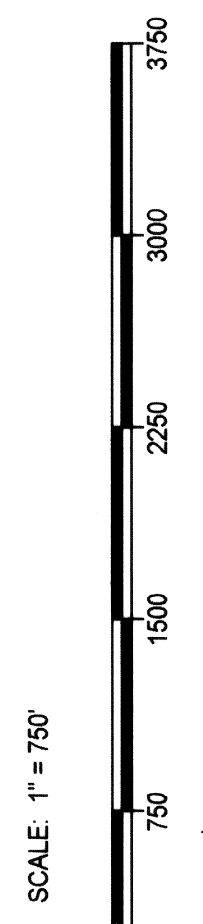
