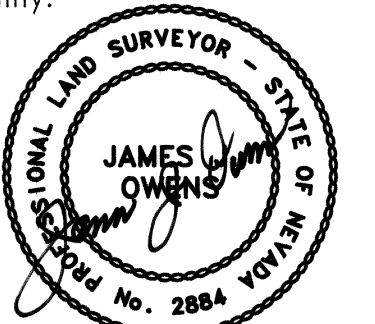

I, James J. Owens, a Professional Land Surveyor registered in the State of Nevada, do hereby certify that :

1. This Plat represents the results of a survey conducted by me, or under my direct supervision at the instance of Rainbow Canyon Ranch, L.L.C.
2. The lands surveyed lie within Sec.'s 7,18 & 19, T. 4 S., R. 67 E., M.D.M. and Sec.'s 24,25,26,35 & 36, T. 4 S., R. 66 E., M.D.M., within a portion of the City of Caliente, Lincoln County, Nevada, and the survey was completed on Dec. 17, 1999.
