Said right-of-way being that of the Union Pacific Railroad.

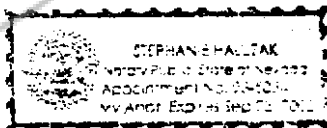

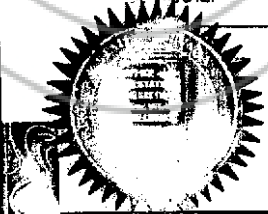
