

9. Further, Affiant sayeth naught.

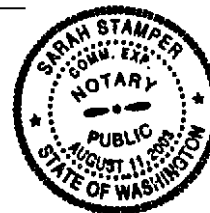

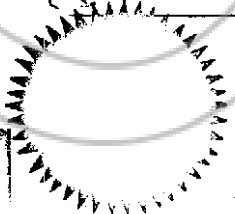
