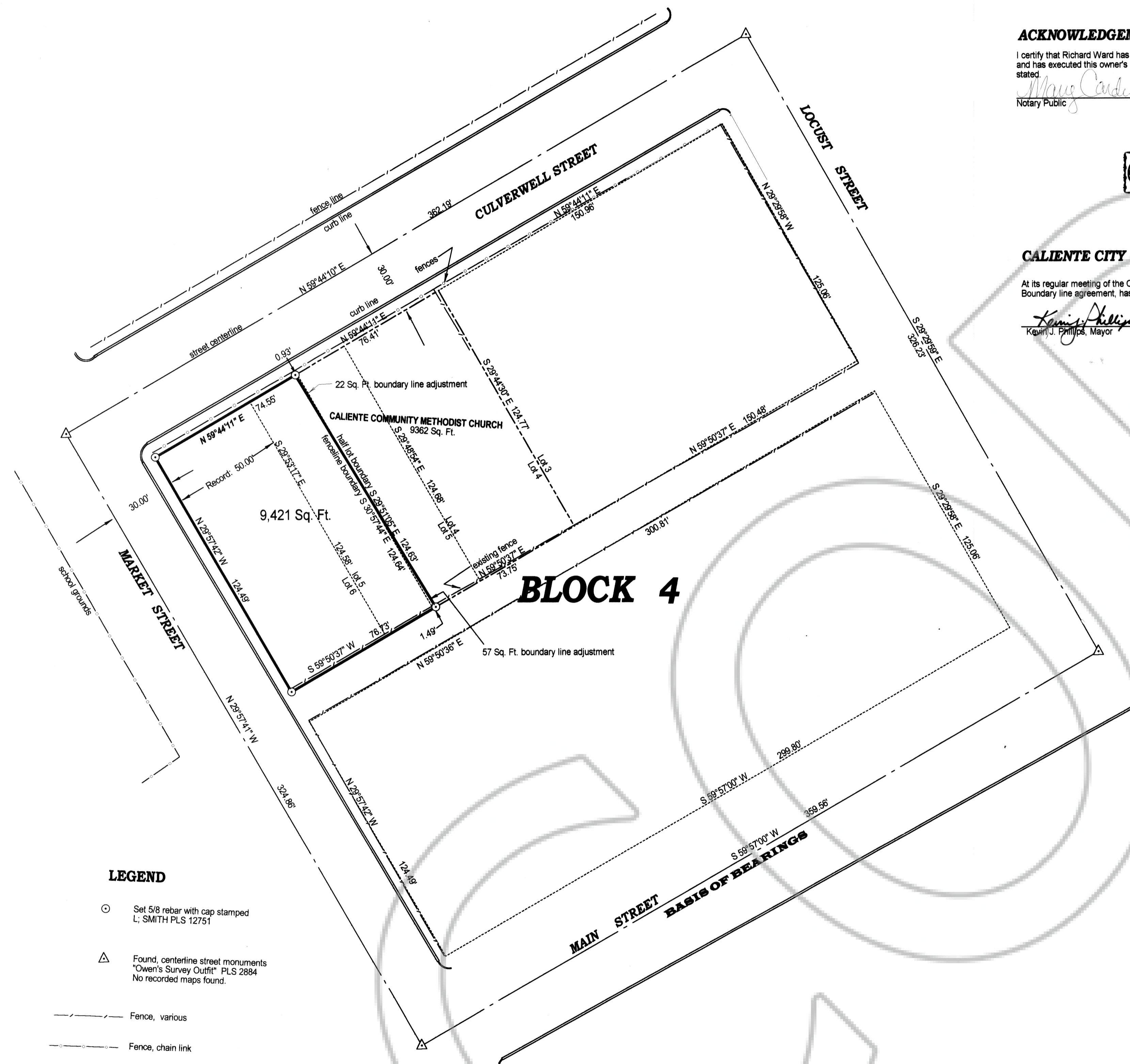
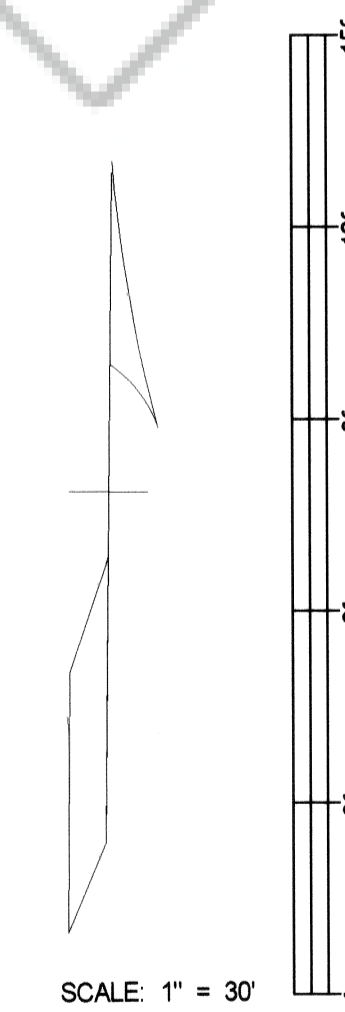


MAP NOTE:
