THIS MATTER came before the Court September 15, 1998, for sentencing. The State of Nevada was represented by the Douglas County District Attorney, and the Defendant was present, represented by Terri Steik Roeser, Attorney at Law. A judgment of conviction was entered pursuant to proceedings taken on that date, which included an order for payment of restitution in the amount of \$3,084.00 to Mary Love. In further proceedings taken June 22, 1999 and August 1, 2000, the Court, having been fully advised, ordered periodic payments on the restitution order and directed entry of a money judgment against the Defendant and in favor of Mary Love.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that judgment enter in favor of Mary Love and against the Defendant, Vernon G. Perkins, in the amount of \$3,048, with credit for
