16 The matter of the Petition for Appointment of a Guardian having been

19 L. DOBRESCU, ESQ., and the Court finding that proper notice of such Petition and

21 SEARS and LILA TERRY, siblings of the above named Ward; that NETTIE MAE
22 LEONARD, JOHN W. TURLEY, PATRICIA SEARS or LILA TERRY did not appear nor
23 have they contested any portion of said Petition; that MICHAEL R. TURLEY is the brother
24 of the said Ward; and the Court having received evidence and argument in support of said
25 Petition, and the Court having considered the same and good cause appearing;

IT IS THE FINDING OF THE COURT that the allegations contained in the verified Petition are true and correct;

IT IS THE FURTHER FINDING OF THE COURT that Petitioner is a fit and proper person to be appointed Guardian of the said Ward and it is in the best interests of TIMOTHY JACOB TURLEY to appoint Petitioner as Guardian over the person and estate of said Ward, and that it would be detrimental to the Ward's best interests to not order such Guardianship;

NOW THEREFORE, IT IS HEREBY ORDERED that Petitioner, MICHAEL R. TURLEY, is hereby appointed as Guardian of the person and estate of TIMOTHY JACOB TURLEY, and that Letters of Guardianship shall be issued to MICHAEL R. TURLEY upon taking his oath of office as required by law.

IT IS FURTHER ORDERED that no bond or other security shall be required to be posted by said Guardian.

IT IS FURTHER ORDERED that Petitioner shall be granted powers as Guardian as set forth in Chapter 159, N.R.S., and specifically, those powers designated in N.R.S. 159.117 to 159.175, inclusive.

IT IS FURTHER ORDERED that a certified copy of this Order be recorded in the Lincoln County Recorder's Office within sixty (60) days of the Guardian's appointment.
