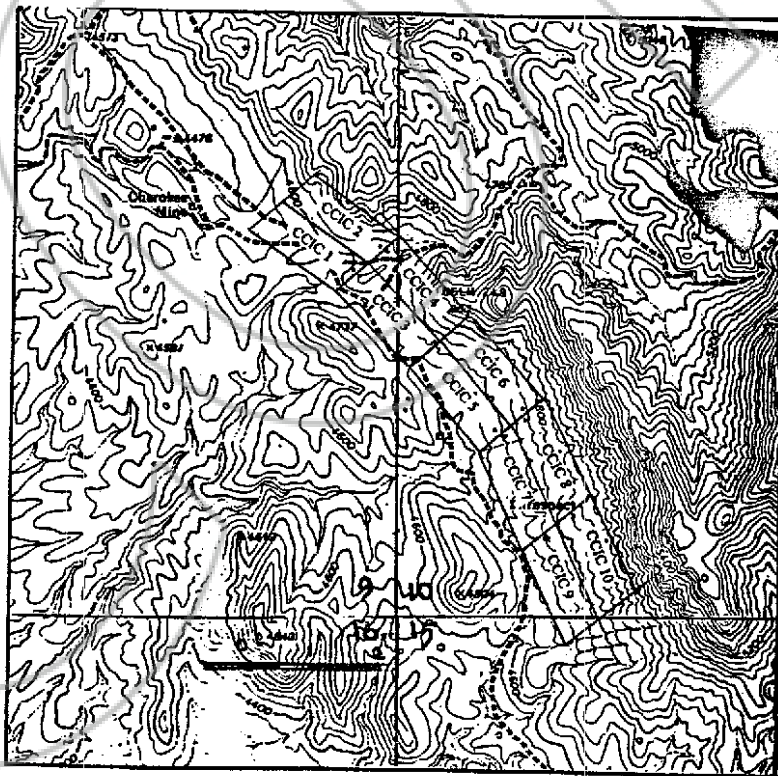

2. The westernmost corner of the claim is 3,600 feet in a S 29 E direction from a survey monument or permanent natural object described as the US Mineral Monument #249 in the SW 1/4 of section 10, T8S, R68E
3. The type of location monument is a 2"x2" wooden post, 5 ft long, or pvc pipe.  
The type of corner end monuments are 2" x 2" x 5 foot wooden posts.
4.
