BASIS OF BEARING

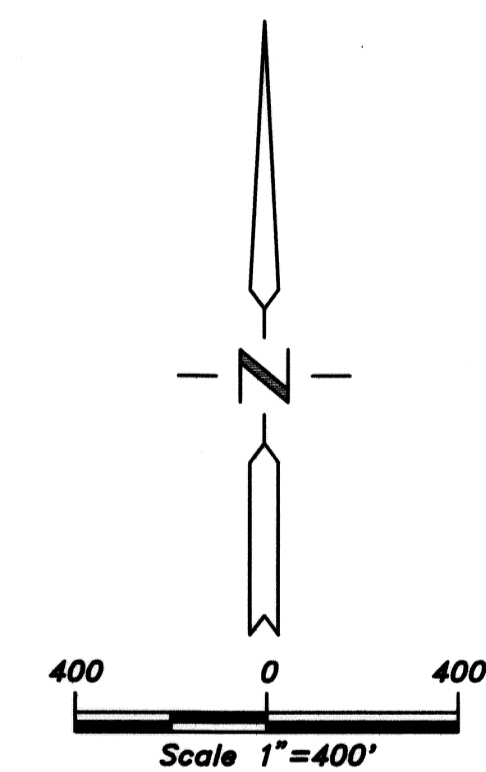
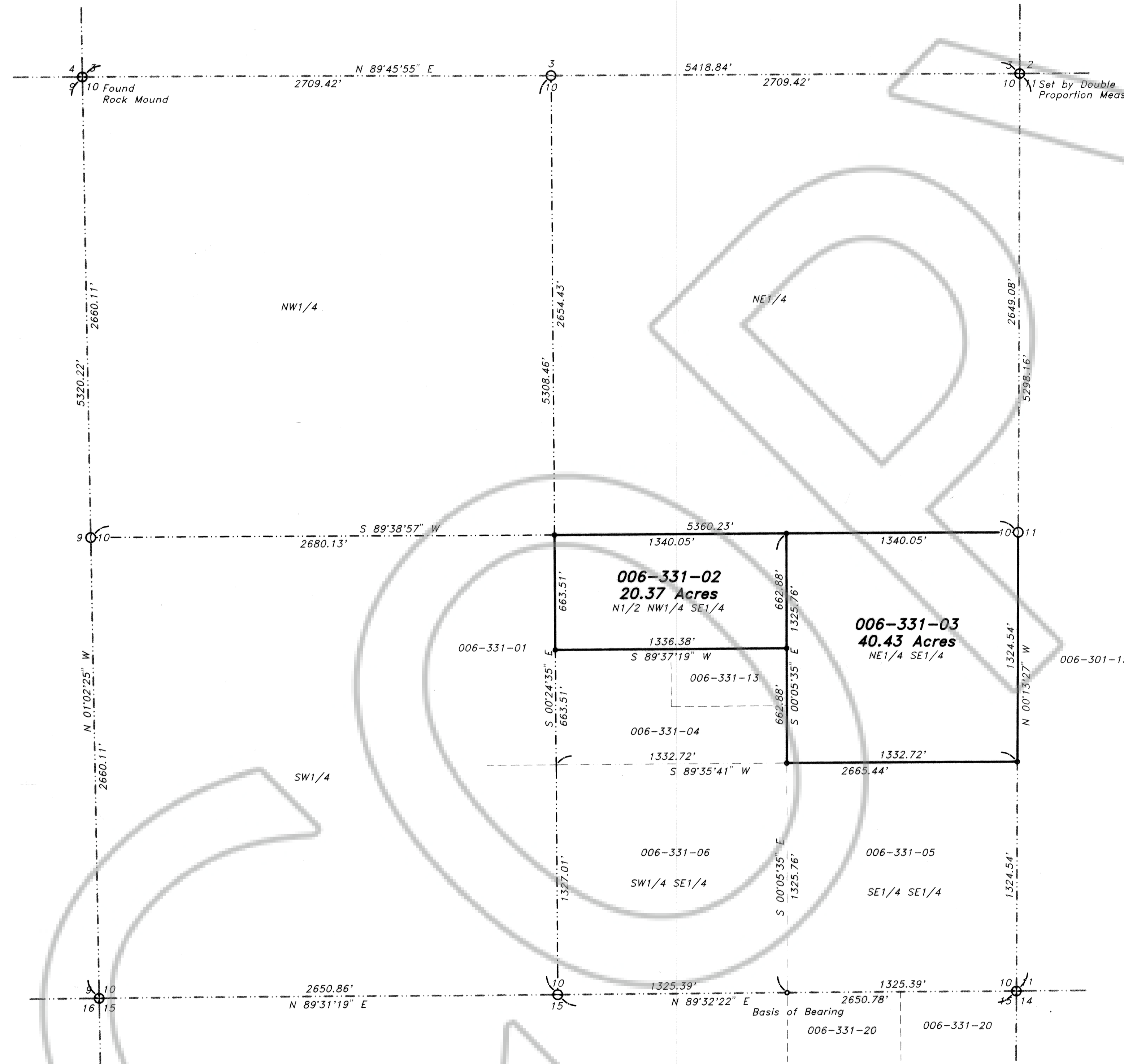
