

HOWARD McCROSKY FAMILY TRUST

This Trust Agreement is made by HOWARD McCROSKY, (sometimes hereinafter called "husband"), and LINDA RUTH McCROSKY, (sometimes hereinafter called "wife"), both of the County of Lincoln, State of Nevada, (hereinafter called the "Grantors"), and HOWARD McCROSKY and LINDA RUTH McCROSKY, both of the County of Lincoln, State of Nevada, as equal Co-Trustees, (hereinafter called the "Trustee" and thereby referred to either individually or collectively as context may require).

1. TRUST PROPERTY

The Grantors will hereafter transfer, by appropriate written instrument duly executed by either or both of them (as the case may be), to the Trustee a sum of cash (in the amount of Ten Dollars (\$10) or more) or legal title of other assets presently owned by either or both of them, which assets shall constitute a part of the original Trust Estate. Thereafter, additional property may be added to the Trust Estate at any time or from time to time, by the Grantors or either of them, or by any person or persons, by inter vivos or testamentary transfer or by insurance or trust designation. All such original and additional property is referred to herein collectively as the "Trust Estate".

The property comprising the original Trust Estate may be the separate property of either of the Grantors, or such property may be community property of their marriage, and, in any event, such property shall retain such character of ownership existing before such transfer. Property received by the Trustee during the joint lives of the Grantors or thereafter need not be listed in any schedule or exhibit attached to this Agreement but shall be a part of the Trust Estate if legal title thereto is taken or registered in the name of this Trust either in the name of both equal Co-Trustees hereunder or in the sole name of either of them as long as such legal title is clearly designated to be held by such Trustee in the name of and under the terms and conditions of this Trust Agreement. Any and all property received by the Trustee under the terms of this Trust Agreement shall, if received from either or both husband and wife, have the same separate property or community property character attributable thereto immediately before receipt thereof by the Trustee.

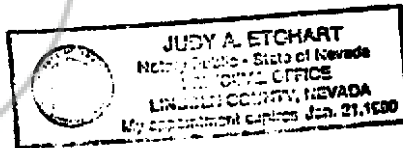
