4 I, FRANK LLOYD, a resident of Lincoln County, State of  
5 Nevada, being of sound mind and disposing memory, do make and  
6 declare this to be my Last Will and Testament, hereby expressly  
7 revoking all prior Wills and Codicils heretofore made by me.

8 SECTION ONE. Marital Status. I am single, having been  
9 divorced.

10 SECTION TWO. Children. I have three living children  
11 whose names and addresses are: ARTHUR MICK LLOYD, Eagle Valley,  
12 Lincoln County, Nevada; LISA KAY ANDREWS, Pioche, Nevada; and  
13 KATHY HALE, Las Vegas, Nevada.

14 I declare that I have no deceased children.

15 SECTION THREE. Disinheritance. I have, except as  
16 otherwise provided in this Will, intentionally and with full  
17 knowledge, omitted to provide for my heirs who may be living at  
18 the time of my death, including any person who may become my heir  
19 by reason of marriage or otherwise after the date of the execution  
20 of this Will. In the event any person or persons successfully  
21 contest this, my Last Will and Testament, then in such event I  
22 leave such person or persons so contesting the sum of One Dollar  
23 (\$1.00) each.

24 SECTION FOUR. Debts. I direct that my Executrix first  
25 pay out of my estate all of my just debts, funeral expenses, and  
26 costs of administration as soon as practical thereafter,

27 SECTION FIVE. Disposition of Body. I hereby leave all  
28 of my funeral arrangements to the sound discretion of my  
29 Executrix named herein.

2 children mentioned in this Section predecease me, I leave that  
3 portion of my estate intended for he or she to my surviving child  
4 or children in equal shares.

5 SECTION SEVEN. Executrix. I nominate and appoint my  
6 daughter, LISA KAY ANDREWS, of Pioche, Lincoln County, State of  
7 Nevada, as Executrix of this Will, to serve without bond. If she  
8 should predecease me, or for any reason be unable to qualify, or  
9 decline to act as Executrix, I nominate and appoint ARTHUR MICK  
10 LLOYD, of Eagle Valley, Lincoln County, Nevada, as Executor of  
11 this Will, to serve without bond.

12 I give my Executrix or Executor herein appointed all the  
13 powers granted to Executors by Nevada Statutes as in effect at the  
14 date of execution of this Will, together with all powers reasonably  
15 incident thereto and necessary for or appropriate for the effective  
16 exercise thereof.

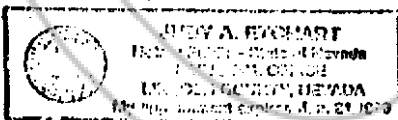
