 WILLIAM HAL ENGLESTEAD AND MARY JANE ENGLESTEAD, husband and wife as joint tenants
 whose address is 2775 East Thurman Ave., Las Vegas, NV. 89120
 WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in the

County of Lincoln State of NEVADA described as:

All of Homestead Patent No. 799633 and Stockraising Homestead Patent No. 996336, issued to Henry I. Olinghouse, described as Lots 2, 3 and 4 and the E 1/2 SW 1/4 and SE 1/4 NW 1/4 of Section 18, Lots 1, 2, 3 and 4, E 1/2 NW 1/4; NE 1/4 SW 1/4; SW 1/4 NE 1/4 of Section 19, and Lot 1 of Section 30, all in Township 4 North, Range 68 East, M.D.B.&M., also NE 1/4 NE 1/4 of Section 25, Township 4 North, Range 67 East, M.D.B.&M.

Together with any and all water rights appurtenant thereto, including, all irrigation and domestic water rights on Page Basin Creek under Certificate of Appropriation 1P0, exclusive of stock watering and range rights thereunder.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$90,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely:

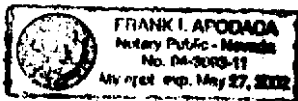
