The claim is approximately 1,500 feet long and 600 feet wide such that 10 feet is claimed in a east direction and 1490 feet in a west direction from the Monument of Location, at which the Notice of Location was posted, together with 300 feet on each side of the Monument of Location and the center line of the claim. The general course of the claim is from the east to the west direction.

Each corner and the location monument of the claim are monumented with a 2 inch by 2 inch by four foot long wooden post with a scribed metal tag indicating the post's location.

The corner monuments were erected within 60 days of the posting of the Notice of Location. To locate the monuments, begin at the northeast corner (No. 1) of the claim and travel:

- 600 feet south to the southeast corner(No. 2), thence;
- 1,500 feet west to the southwest corner(No. 3), thence;
- 600 feet north to the northwest corner(No. 4), thence;
- 1,500 feet east to the southeast corner(No. 1).

The location work consists of the making of a claim map as provided in NRS 517.040, a copy of which is filed with the Lincoln County Recorder and is herein incorporated by this reference.
