17 **STIPULATED JUDGMENT**

18 IT IS HEREBY STIPULATED AND AGREED by and between PROVIDIAN  
19 NATIONAL BANK, ("Plaintiff"), and QUEEN M. HARRINGTON, ("Defendant(s)"), that  
20 Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the amount of  
21 \$8,497.10, plus interest on the principal balance in the amount of \$3,332.45, along with Plaintiff's  
22 costs of suit in the amount of \$146.00, and Plaintiff's attorney's fees in the amount of \$250.00,  
23 less amount paid of \$2,056.00, together with interest on the principal balance at the mutually  
24 agreed rate of (11.50%) per annum from April 12, 2001 until this debt is paid in full.

25 It is further stipulated and agreed that this Judgment shall be paid as follows:

26 1. Payments shall be made in an amount of no less than \$300.00 per month by the 30th  
27 day of every month, with the first payment being due on or before April 30, 2001.


28 2. No further notice shall be given to the Defendant(s) regarding payment and there is  
no grace period.

3. It is further understood by the Defendant(s) that if the Plaintiff has not received  
payment as previously stipulated, the terms of this agreement will no longer be in effect.

1 Thereafter, Plaintiff may obtain an execution from the Court and may demand payment in full on  
2 the remaining Judgment balance.



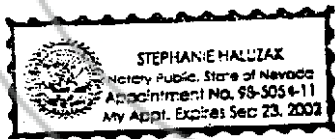


