In accordance with the provisions of NRS No. 278.473, it is hereby requested that the map be amended in the following manner:

The NW1/4NW1/4 of Section 11 was erroneously labeled as NE1/4NE1/4, and will be correctly read as the NW1/4NW1/4.

Also added are the identification of the north and east quarter corners, and the east reference monument to the west quarter corner should read N29°53'14"W instead of N29°53'14"E. Additionally the B.L.M. Basis of Bearings is shown as N89°42'W, and should be N89°20'E.




