Open Letter to Senator Harry Reid From Citizens of Lincoln County:

Honorable Senator Reid:

We are deeply concerned about the social and economic effect which the Lincoln County Land Act sales will have on our communities and our way of life. We are also concerned about the way the process leading up to the October 12 sales are being carried out.

When our County Commissioners were informed of our concerns they pointed out this is a BLM action and is taking place under a Congressional Deadline. We are grateful for your efforts to release land to improve the country's tax base and we appreciate all the hard work that you have done to facilitate this project. However, at this time we must respectfully request your help to postpone the sale until the concerns of country residents can be heard and addressed through an open process faltinful to the spirit of NEPA AND FLPMA as well as other federal laws.

We are concerned about the ramifications of the Lincoln County Land Act. We are grateful for your efforts to return land to the tax base, however, the amount of land being disposed of completely away from our traditional population centers creates a massive new community on the county line. The density of the new community on the county line with 100,000 plus residents will quickly overpower the 4,000 residents that exist in the county. Our County Commission sees dollar signs and have been convinced this is an economic development project. It is, for Mesquite. For Lincoln County it is the destruction of their rural lifestyles, it is the shifting of values from rural to urban, it is the complete reversal of their current lives. While this may mean jobs in Mesquite, it will mean a dollar drain on the current taxpayers. It also means the imposition of urban ideals on a county that has held on to it's rural mots. We need jobs, Senator, Yes we do. What we don't need is one more challenge for our fragile economy to overcome, and this would appear to be too much to overcome. The land act gives money to the StM to acquire land, the environmentally sensitive land they seek is our only private property, this will further throw the county into flux.

There has been no open public process on this issue in Lincoln County. The general population was not able to participate in any of the scoping for the process, no planning hearings were ever held, and the public has not had adequate time to study the impacts both immediate and the future.

ALL THE INFORMATIONAL MEETINGS, ALL THE SCOPING HEARINGS AND EVEN THE SALES ARE IN MESQUITE. THIS IS THE LINCOLN COUNTY LAND ACT AND MOST LINCOLN COUNTY CITIZENS DON'T KNOW A THING ABOUT IT.

The NEPA process for the Lincoln County Land Act was cursory, the comments prepared by the Lincoln County Public Lands Commission and the Lincoln County Planning Commission were suppressed by the Lincoln County Commission. In short, Senator, the sale needs to be held up for at least a year while the citizens of Lincoln County find our how this may impact them and if the land and it's alleged tax increases are an acceptable price to pay for growth. Can we afford to provide services in the limbo between development and tax revenues? Can we afford to pay the satellite offices Clark County wages and then the current county employees as well because the county cannot discriminate against it's workers?

This entire idea has not been well thought out and until it is, the whole project should be put on hold. Senator, we appreciate all the hard work that was done to facilitate this project, but the affected people were kept in the dark and they need time to approve or disapprove this massive change to our lives and livelihoods.

Senator, we know you were instrumental in getting this act passed, we know the deadline was so that BLM could not drag this out into decades, a good idea, one that needs more thought. Would it be too difficult for you to delay it for a year while the residents of the county study the good and bad and see how it will be balanced against our futures?
