For the purpose of securing (1) payment of the sum of \$10,700.00 with interest thereon according to the terms of a promissory note or notes of even date hereinafter made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may thereafter be loaned to Trustor, or to his successors or assigns, which evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.


