# ORDER SETTING ASIDE ESTATE WITHOUT ADMINISTRATION AND APPROVING ESTATE SETTLEMENT AGREEMENT

The petition of FRANCES DONOHUE for the entry of an order that the Estate of her husband, Richard Donohue, Deceased, shall not be administered upon, but the whole thereof shall be by the Judge assigned and set apart to her as the sole claimant thereof and the person entitled thereto, in accordance with the Estate Settlement Agreement, dated April 21, 1998, by and between Frances Donohue and Owen Donohue (the Decedent's brother), coming on regularly this day to be heard; due proof having been made to the satisfaction of this Court that Notice of the filing and of the time and place for hearing said petition was given in manner and form as required by NRS 155.010; the Court having read said petition and having heard or read all evidence presented in support thereof and having considered the same and being fully advised in the premises, finds and adjudges;

That the said Richard Donohue died intestate on or about the 20th day of March, 1997, and was, at the time of his death, a resident of Pioche, Nevada, Lincoln County, leaving Frances Donohue as his

surviving spouse, and Owen Donohue, his brother, as his sole surviving heirs, and leaving the Estate consisting of the property listed on Exhibit "A" hereto; that the gross value of said Estate is not in excess of fifty thousand dollars (\$50,000.00); that the funeral expenses of Decedent were paid by Petitioner; that said Petitioner is entitled to such Estate for her support, subject to the provisions of the Estate Settlement Agreement attached hereto as Exhibit "B" and subject to any outstanding claims against the Estate, to the extent such claims are legally enforceable against Petitioner.

NOW, THEREFORE, IT IS ORDERED that the said Estate of Richard Donohue, Deceased, consisting of the assets set forth on Exhibit "A" hereto, shall not be administered upon, but the whole thereof shall be, and is hereby, assigned and set apart to Frances Donohue, subject to the provisions of the Estate Settlement Agreement attached hereto in Exhibit "B," which is hereby approved.

IN ACCORDANCE WITH THE FORGOING, IT IS SPECIFICALLY FURTHER ORDERED AS FOLLOWS:

1. Frances Donohue, Petitioner, shall hereby have vested in her name all right, title and interest in and to the real property located at No. 13 Main St., Pioche, Nevada, more particularly described as follows:

## ESTATE SETTLEMENT AGREEMENT

THIS ESTATE SETTLEMENT AGREEMENT made and entered by and between OWEN DONOHUE of Lincoln County, State of Nevada hereinafter referred to as "OWEN", and FRANCES DONOHUE, sole heir of the ESTATE OF RICHARD DONOHUE, hereinafter referred to as "FRANCES".

## RECITALS:

WHEREAS, there is pending in the Seventh Judicial District Court in and for the County of Lincoln, State of Nevada, the ESTATE OF RICHARD DONOHUE, Deceased, Case No. 9-6-97LP; and,

WHEREAS, OWEN DONOHUE asserts a claim to the Estate by virtue of the fact that he is the brother of RICHARD DONOHUE, Deceased, and therefore has a statutory interest in said Estate; and,

WHEREAS, FRANCES and OWEN believe it is in the best interest of each party to resolve all claims and issues regarding the estate;

WHEREAS, FRANCES DONOHUE, is the only other heir to the Estate other than OWEN DONOHUE;

NGW, THEREFORE, based upon the mutual covenants contained herein, the parties agree as follows:

#### ARTICLE I

#### DIVISION OF PROPERTY

OWEN shall execute any and all documents necessary to transfer any interest in and to any of said personal property to FRANCES DONOHUE and or the ESTATE.

SECTION 1.05. Personal Property to OWEN DONOHUE. OWEN shall receive any personal belongings\personal property that were owned or possessed by LELAND DONOHUE and/or SADIE MAY DONOHUE. OWEN has possession of said items of personal property and shall not make any further claims to any other personal property.

SECTION 1.06. Set- Aside of Estate. FRANCES DONOHUE shall file an Amended Petition in THE ESTATE OF RICHARD DONOHUE and shall seek therein to set aside the real and personal property

pursuant to the terms of this Estate Settlement Agreement.

## ARTICLE II

## ESTATE PROCEEDINGS CONCERNING SADIE MAY DONOHUE

#### AND\OR LELAND DONOHUE

SECTION 2.01. Set-Aside of Estate. OWEN DONOHUE shall initiate estate proceedings to set-aside the estate of SADIE MAY DONOHUE and/or LELAND DONOHUE to OWEN. FRANCES DONOHUE shall execute any and all assignments of interest, disclaimers of title, or other documents as may be appropriate to relinquish any interest that she may have in and to No. 1 Mill Street, Pioche, Nevada, as more particularly described above. In the event that it is determined that the real property located at No. 2 Mill Street, Pioche, Nevada, forms part of the estate of SADIE MAY DONOHUE and/or LELAND DONOHUE, the same shall be set-aside to FRANCES DONOHUE and OWEN shall execute any and all documents including disclaimers of title, or assignments of interest that may be required to vest title to said real property in the name of FRANCES DONOHUE.

### ARTICLE III

#### MISCELLANEOUS

SECTION 3.01. Modification. No alteration or other modification of this agreement shall be effective unless such modification shall be in writing and signed by the parties hereto.

SECTION 3.02. Binding Effect. This agreement shall inure to the benefit of and be binding on the heirs, executors, administrators, assigns, devisees, and legatees of the parties.
